TO
ARTICLES OF INCORPORATION
OF
360 ms CORP.**

360 ms Corp. (hereinafter called the "Corporation"), a corporation formed under and by virtue of the Florida Business Corporation Act (the "FBCA"), does hereby certify:

1. The name of the Corporation is 360 ms Corp.
2. The Articles of Incorporation of the Corporation are hereby amended by deleting Article I in its entirety and substituting in lieu thereof the following:

**"ARTICLE I
NAME**

1. The name of this corporation is C3/CustomerContactChannels, Inc. (the "Corporation").
3. The Amendment to the Articles of Incorporation of the Corporation (the "Amendment") was adopted by the sole shareholder of the Corporation, by written consent on May 27, 2010.

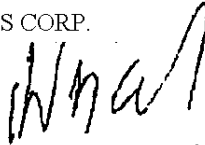
