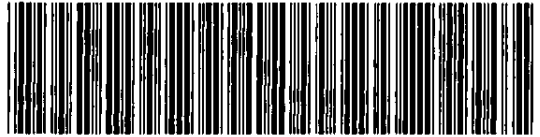

## ARTICLE VII – AMENDMENT


These Articles of Incorporation may be amended from time to time in a manner provided by law.
