ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ROUNDPOINT TAVISTOCK INVESTMENTS, INC.

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of ROUNDPOINT TAVISTOCK INVESTMENTS, INC. are hereby amended as follows:
