ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

Article I NAME

The name of the corporation is ADM Companies, Inc.

Article II PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 361 West 24th Street, Riviera Beach, FL 33404.

Article III PURPOSE

- (a). <u>Number</u> This corporation shall have two (2)) directors initially. The number of directors may be increased or diminished from time to time as provided by the bylaws (but subject in all events to the provisions of (d), below), but shall never be less than one.

The board of directors is hereby specifically authorized to make provisions for reasonable compensation to its members for their services as directors, and to fix the basis and conditions upon which such compensation shall be paid. Any director of the corporation may also serve the corporation in any other capacity and receive compensation therefore in any form.
- (d) <u>Changes in Directors</u>. Any change in the number of directors or election of new directors, or both of them, may be accomplished only upon the affirmative vote of at least seventy-five (75%) percent of the common stock of the corporation then issued and outstanding.

Article VI INITIAL REGISTERED OFFICE AND AGENT

Article VII INCORPORATOR

Article VIII INDEMNIFICATION

This Corporation shall indemnify any and all of its directors, officers, employees or agents or former directors, officers, employees or agents or any person or persons who may have served at its request as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise in which it owns shares of capital stock or of which it is a creditor, to the full extent permitted by law. Said indemnification shall include, but not be limited to, the expenses, including the cost of any judgments, fines, settlements and counsel's fees, actually and necessarily paid or incurred in connection with any action, suit or proceeding, whether civil, criminal, administrative or investigative, and any appeals thereof, to which any such person or his legal representative may be made a party or may be threatened to be made a party by reason of his being or having been a director, officer, employee or agent as herein provided. The foregoing right of indemnification shall not be exclusive of any other rights to which any director, officer, employee or agent may be entitled as a matter of law or which he may be lawfully granted.

Any change, amendment or modification of these Articles of Incorporation may be accomplished only upon the affirmative vote of at least seventy-five (75%) percent of the common stock of the corporation then issued and outstanding.
