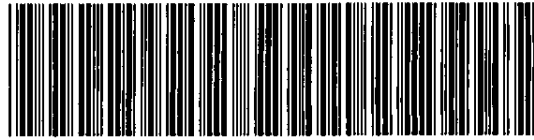

**Article I  
Name**

The name of this corporation is GORMAN, INC.

**Article II  
Principal Office Address**


