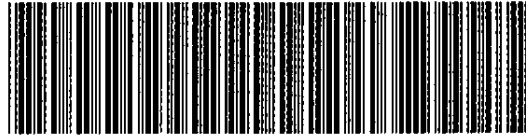




**ARTICLE III. APPROVAL OF DISSOLUTION**
