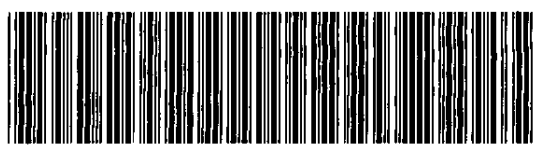

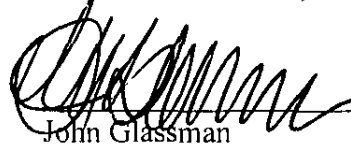

**ARTICLES OF INCORPORATION  
OF

The undersigned Incorporator to these Articles of Incorporation, a natural person, competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

**ARTICLE I. CORPORATE NAME**

The name of this corporation shall be **LIVINGSTON PROPERTIES OF NORTHWEST FLORIDA, INC.**

**ARTICLE II. INITIAL PRINCIPAL OFFICE**

The street address, and the mailing address of the initial principal office of the Corporation is: 2350 Hwy 97 North, Molino, Florida 32577.

**ARTICLE III. CAPITAL STOCK**

The number of shares the corporation is authorized to issue is 1,000. No preemptive rights are to be granted to shareholders, and no par value is assigned to the shares.

**ARTICLE IV. REGISTERED OFFICE AND INITIAL REGISTERED AGENT**

**ARTICLE V. INCORPORATOR**

**ARTICLE X. OFFICERS**

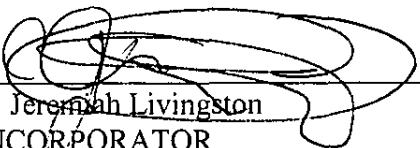

**ARTICLE XI. AMENDMENT**

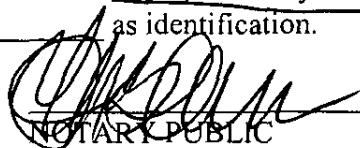

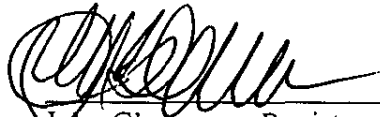
