ARTICLE IX. RESTRICTION ON ALIENABILITY OF SHARES

Notwithstanding Article IX, if a shareholder wishes to sell all or part of the shares owned by shareholder of Hispanica Foods, Inc., shareholder must first offer shares to Hispanica Foods, Inc. If Hispanica Foods, Inc. refuses to purchase shares within 30 calendar days, shareholder must then offer shares to other shareholders of Hispanica Foods, Inc. (if applicable). If other shareholders of Hispanica Foods, Inc. refuse to purchase shares within the next 30 calendar days following Hispanica Foods, Inc.'s rejection, shareholder may then offer shares to individuals outside of Hispanica Foods, Inc. and remaining shareholders of Hispanica Foods, Inc.

ARTICLE X. BUY-SELL AGREEMENT

Upon Hispanica Foods, Inc. obtaining a proper insurance policy, should any shareholder pass away during ownership of Hispanica Foods, Inc. shares, the following shall occur:

- 1. Ownership of shares shall pass to shareholder's beneficiar(ies),
- 2. Death benefit shall pay out to Hispanica Foods, Inc.
- 3. Hispanica Foods, Inc. shall then use the funds to purchase shares from the beneficiary,
- 4. The beneficiary must then sell the shares to Hispanica Foods, Inc. and Hispanica Foods, Inc. must purchase the shares for an amount equal to the Death Benefit, and
- 5. Only a unanimous decision by the board of directors of Hispanica Foods, Inc. prior to death of shareholder may Buy-Sell agreement be waived.

ARTICLE XI. PREEMPTION PROVISION

This corporation elects to have preemption rights.

ARTICLE XII. EFFECTIVE DATE
