We, the indersigned, do hereby associate ourselves together and subscribe These Articles of theorporation for the purpose of forming under the laws of state of Florida, Charter 507 and subject to the fallowing provisions:

### ARTICLLE:

The name of the Corporation shall be: C.I.R OF MIAMI, CORP.

# ARTICLE TWO

This corporation shall have perpetual existence and may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The general nature of business to be transacted by this corporation shall be:
