

## ARTICLES OF INCORPORATION OF SARASOTA SUPERIOR CONCRETE, INC

#### ARTICLE I

Name. The name of this corporation is SARASOTA SUPERIOR CONCRETE,

#### ARTICLE II

Duration. The corporation shall be perpetual.
