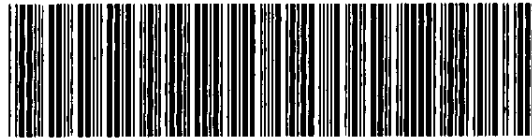

ARTICLES OF INCORPORATION  
OF  
MI-WAY, INC

ARTICLE I

Name. The name of this corporation is MI-WAY, INC.

ARTICLE II

Duration. The corporation shall be perpetual.

ARTICLE III

Purpose. This corporation is organized for the purpose of transacting any or all lawful business.


ARTICLE XI




