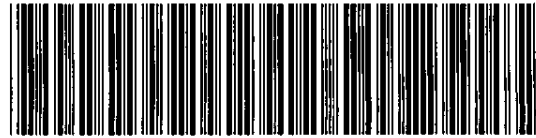

### ARTICLE XIII- AMENDMENT




