

ARTICLES OF INCORPORATION OF NORTH TAMPA RADIOLOGY CONSULTANTS, P.A. (A Florida Corporation)

ARTICLE I NAME

The name of this Corporation is NORTH TAMPA RADIOLOGY CONSULTANTS, P.A. (hereinafter called the "Corporation").

ARTICLE II ADDRESS

The address of the principal office and the mailing address of the Corporation shall be: 6983 East Fowler Avenue, Tampa, Florida 33617.

ARTICLE III DURATION

The period of the duration of the Corporation is perpetual unless dissolved according to law.

ARTICLE IV PURPOSES

This Corporation is organized for the practice of medicine, and all activities related or incidental thereto, and all activities permitted for such a corporation and for which such a corporation may be organized under Florida law, including Florida Statutes Ch. 621, as in effect from time to time or any successor thereto, so far as is or may be permitted by the laws of the State of Florida.
