ARTICLES OF INCORPORATION
OF
J. M. TILLERY & ASSOCIATES, P. A.

The undersigned, for the purpose of forming a corporation under Chapter 621, Florida Statutes, the Professional Service Corporation Act, does hereby adopt the following Articles of Incorporation.

Article I – Name

The name of this corporation shall be **J. M. Tillery & Associates, P. A.**

Article II – Federal Employer Identification Number

The Federal Employer Identification Number of this corporation is **80-0526827**

Article III – Commencement and Duration

This corporation shall have perpetual existence. The date and time of the commencement of corporate existence shall be effective with the filing of these Articles of Incorporation.

Article IV – Purpose

The general nature of the business to be transacted by this Corporation is to operate and maintain an establishment and otherwise serve the convenience of its shareholders in carrying on and engaging in the practice of media brokerage and consulting, and, in general to engage in any and all lawful business permitted under the laws of the United States and the State of Florida, as well as to transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.

Article V – Capital Stock

The aggregate number of shares of Capital Stock which this corporation is authorized to issue is One Thousand (1,000) shares. Such shares will be a single class, Class A Common Stock, and shall have a par value of One Dollar (\$1.00) per share.

The power to adopt, alter, amend or repeal the by-laws of this corporation shall be vested in the Board of Directors and shareholders.

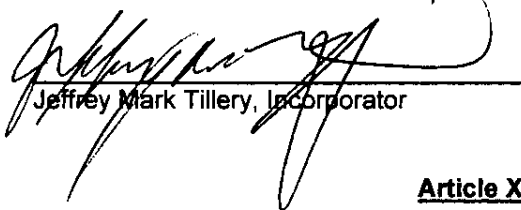
Article XII – Small Business Election

Article XIV – Indemnification

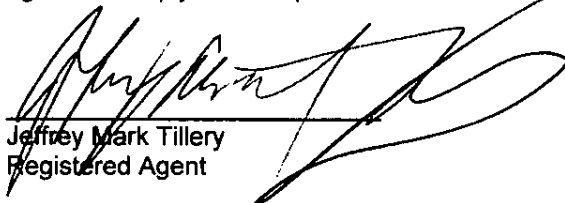
This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

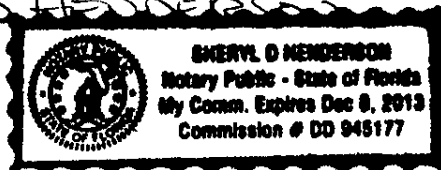
