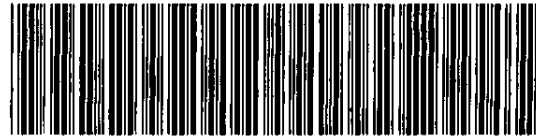

The undersigned, acting as incorporator of the captioned professional association under the Professional Service Corporation Act pursuant to Chapter 621 of the Florida Statutes, adopts the following Articles of Incorporation.

**ARTICLE I.  
NAME AND PRINCIPAL OFFICE**

**ARTICLE II.


