ARTICLE I. CORPORATE NAME.

ARTICLE II. CORPORATE ADDRESS

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 of common stock and of one series only. ARTICLE XV. INDEMNIFICATION


This corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

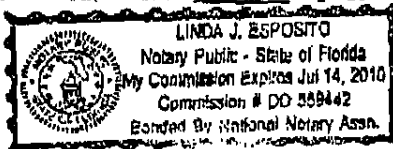
