ARTICLE I - NAME

The name of this corporation is Craig A. Sainz, D.C., P.A.

ARTICLE II - ADDRESS

ARTICLE III - CAPITAL STOCK

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

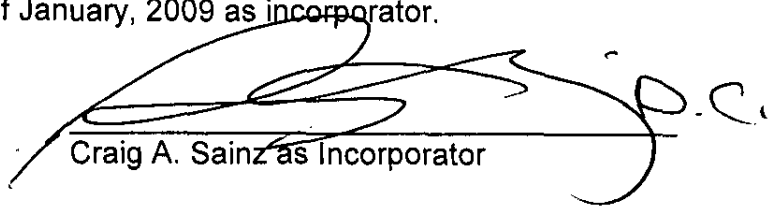
ARTICLE XI - AMENDMENT

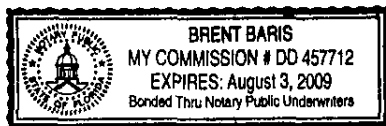
