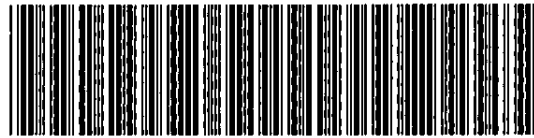

ARTICLE XI AMENDMENT

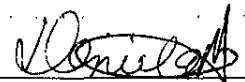
These Articles of Incorporation may be amended in the manner provided by law.

Stock certificates to replace lost or destroyed certificates shall be issued only in accordance with the by-laws of this corporation.

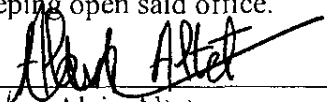
