The name of this corporation is: FELCO BROS. INC.

This corporation shall have perpetual existence.

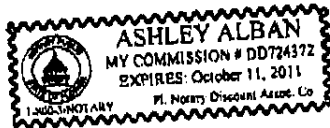




