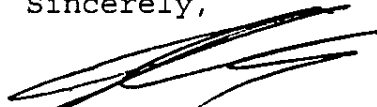

ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of this corporation is EVEREST WASTE SYSTEMS, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

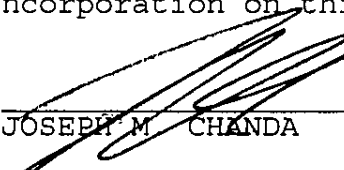

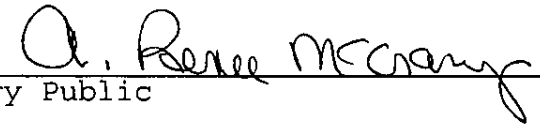

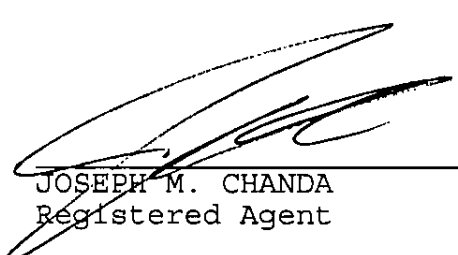
