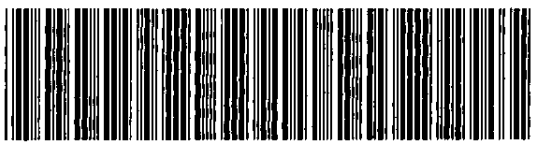



The undersigned for the purpose of forming a for-profit corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation shall be **Rev. Cedric W. Mays International Ministries, Inc.** (hereinafter called the "Corporation").

ARTICLE II
PRINCIPLE OFFICE AND MAILING ADDRESS

The principle office and mailing address of the Corporation shall be 6550 Adriatic Way, West Palm Beach, Florida 33413.

ARTICLE III
PURPOSE

The Corporation is a for profit organization organized for the purpose of engaging in any lawful act or activity for which for profit corporations may be organized so for as or may be permitted by the laws of the State of Florida. The specific purpose of the Corporation is to develop, brand, market and manage Rev. Cedric W. 
