ARTICLE I – NAME

The name of the organization shall be the Coalition of Jamaican Alumni Associations of Florida (CJAAF), Inc.

ARTICLE III - PURPOSE

The Coalition of Jamaican Alumni Associations of Florida (CJAAF), Inc. is dedicated to the advancement of Jamaican Alumni Associations in South Florida and educational institutions in Jamaica through the mobilization of resources of graduates in the State of Florida.

The purpose for which the corporation is organized is:

- To be involved in, support, and promote community work in Florida and the United States.
- 2. To assist in the dissemination of information about Jamaican alumni associations registered in the State of Florida and to help in the unification and streamlining of activities of these associations.
- 3. To keep the Jamaican community in Florida informed about matters pertaining to Jamaican alumni associations in Florida, and issues relating to the development of education in Jamaica.
- 4. To serve as a central repository for information on Jamaican alumni associations in Florida.
- 5. To provide financial and volunteer assistance to students and educational institutions in Jamaica and Florida
- 6. To help in the unification and streamlining of activities of Jamaican Alumni Associations in Florida.

- To foster, through periodic seminars, social and entertainment activities, a spirit of fellowship, cooperation among and between Jamaican alumni associations in the United States
- 8. To further, by directed studies, research and publication, knowledge of Jamaican alumni associations, and to promote, through association, seminars and general cooperation with other organizations or individuals similarly interested, the philosophies, attitudes and cultures of Jamaica.

ARTICLE 1V MANNER OF ELECTION- THE MANNER IN WHICH DIRECTORS ARE APPOINTED

All Jamaica alumni associations registered in the State of Florida are eligible for membership in the Coalition of Jamaican Alumni Associations of Florida (CJAAF), Inc. All registered members of Jamaican alumni associations in Florida are members of the Coalition of Jamaican Alumni Associations of Florida, Inc.

- 1. The officers of the Coalition of Jamaican Alumni Associations of Florida (CJAAF), Inc. shall be the two incorporators that will serve as the Managing Partners with shared responsibilities for the duties of Public Relations Officer, Treasurer, and Secretary.
- There is also a Planning Board consisting of the Managing Partners, eight representatives elected by the general membership from 8 alumni associations, and three appointed advisors from the community.
- 3. The selection process from the 8 representatives from the alumni associations is carried out by an electoral committee consisting of three (3) individuals. If any electoral committee member is nominated, another member will replace him/her on the election committee.
- 4. Nominations of Planning Board members shall be made by online email, phone call (with caller ID enabled, calling from a registered phone number), mail, or in person at the general meeting.
- 5. A notice will be sent to the nominated person within five (7) days of the nomination by email, phone call (with caller ID enabled, calling from a registered phone number), and mail. The nominee has five (5) days to decline the nomination. All accepted nomination would be posted on the Coalition of Jamaican Alumni Associations of Florida (CJAAF), Inc. web page.
- 6. A one paragraph personal advertisement or campaign note (including resume) is optional for each nominee.
- 7. The election of Planning Board members shall be conducted using mail or secret ballot by attending the general meeting where the votes will be counted by the election committee.

- a. Voting shall last for a period of two (4) weeks prior to the general meeting.
- b. A simple major is needed for all the offices.
- c. In the event of a tie, a run-off is necessary to determine the winner
- 8. Upon installation of the Planning Board members whose terms begin at the close of the Annual Meeting, or after a dismissal, all documents, records, materials pertaining to the duties of the office as designated in the bylaws, shall be submitted to the newly elected counterpart within fifteen days of the installation.
