**ARTICLE 1
NAME AND ADDRESS**

The name of this corporation shall be 3221-3313 CHIQUITA, INC. The initial principal business address of the corporation is 1565 Red Cedar Drive, Fort Myers, Florida 33907.

**ARTICLE 2
DURATION**

The corporation shall commence upon the filing of these Articles and shall have perpetual existence thereafter.

**ARTICLE 3
PURPOSE**
