ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
SEMANCIK CONSULTING GROUP, INC.

SEMAMCIK CONSULTING GROUP, INC., a Florida corporation (the "Corporation") whose Articles of Incorporation were originally filed with the Florida Department of State on April 21, 2010 (Florida Division of Corporations Document Number P10000034736), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

"ARTICLE I

CORPORATE NAME AND PRINCIPAL OFFICE

*The name of this corporation is **PEAK SOLUTIONS CORPORATION** (the "Corporation") and its principal office and mailing address is 3374 Summerfield Cove, Palm Harbor, Florida 34683.*

2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.

3. The amendment recited in Section 1. above has been duly adopted in accordance with the provisions of §607.0821, .0704, .1003 and .1006, Florida Statutes, the shareholders and directors of the Corporation having executed a written statement, dated effective December 5, 2011, manifesting their intention that the amendment be adopted.
