ARTICLES OF INCORPORATION
OF
AMERICAN CRAFTSMEN OF FLORIDA, INC.

In compliance with the requirements of Florida Statute Chapter 607, the undersigned, being natural persons, hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I. NAME

The name of the Corporation ("Corporation") is AMERICAN CRAFTSMEN OF FLORIDA, INC.

ARTICLE II. PURPOSE

The purpose for which the corporation is organized is:

To engage in any activity or business authorized under the Florida Statutes. Further, and in general, to carry on any and all incidental business; to have and exercise all the powers conferred by Florida Statute Chapter 607 and other applicable laws of the State of Florida, and to do any and all things set forth in these Articles and to the same extent as a natural person might or could do except as otherwise set forth in these Articles or in the By-Laws of the corporation.
