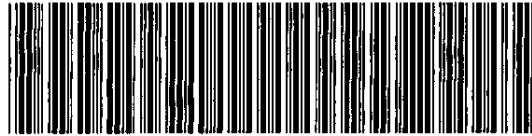

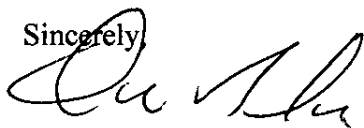

ARTICLES OF INCORPORATION
OF
FHTM DAYTONA, INC.

The undersigned subscriber, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida, and adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be FHTM DAYTONA, INC..

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The initial principal place of business of this corporation in the State of Florida shall be 10 Sweetmeadow Court, Ormond Beach, FL 32174. The Board of Directors from time to time may move the principal office to any other address in Florida.

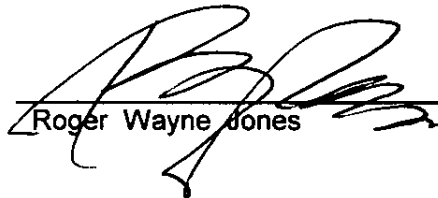
ARTICLE XI - AMENDMENT

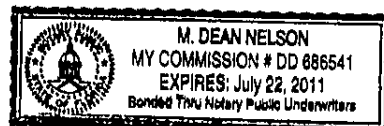

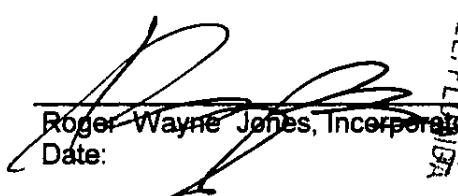
