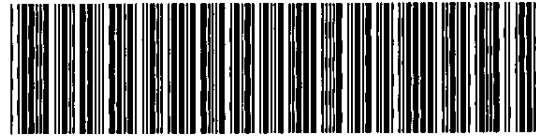

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit, under the laws of State of Florida.

ARTICLE I. NAME

The name of this Corporation is **PC INTERMODAL, INC.**

ARTICLE II. NATURE OF BUSINESS

The general character, purpose, and nature of the business is to engage in the trucking business, and any other lawful business in the State of Florida and elsewhere.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock at a par value of \$1.00 per share.

ARTICLE IV. TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE V. INITIAL PRINCIPAL OFFICE ADDRESS

The name and street address of incorporator to these Articles of Incorporation is Joanna Phillips, 3399 Olympic Drive, Green Cove Springs, Florida 32043.

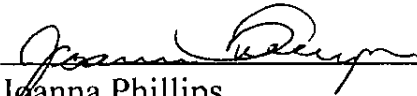
ARTICLE X. EFFECTIVE DATE

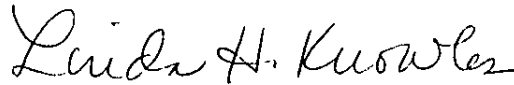
