**ARTICLES OF INCORPORATION
OF
MID FLORIDA HEALTHCARE MANAGEMENT, INC.**

ARTICLE I - NAME

The name of the corporation shall be Mid Florida Healthcare Management, Inc. (hereinafter, the "Corporation" or the "Company").

ARTICLE II - PURPOSE

The purpose for which the Corporation is organized is to engage in the conduct of any and all lawful activity or business.
