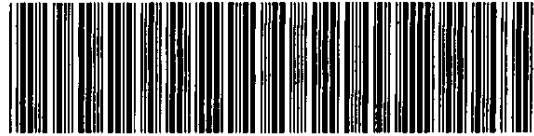



The undersigned incorporator, for the purpose of forming a profit corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME.

The name of the for profit corporation shall be A & F Enterprises of Citrus County, Inc.




