## ARTICLES OF INCORPORATION

OF

#### SHEPPARD LAWN & CLEANING SERVICES\_INC.

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

#### ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is <u>SHEPPARD LAWN & CLEANING SERVICES, INC.</u> hereinafter referred to as the "Corporation".

#### ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS
