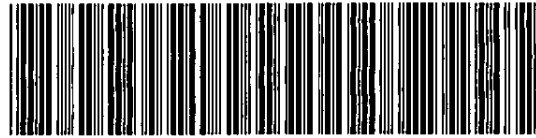


**ARTICLE NINE**
