ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name and mailing address of this corporation shall be-

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commerce its existence upon the signing of these Articles of Incorporation by the initial subscribers.
