ARTICLE I
Name

The name of the Corporation shall be Pure Pest Management, Inc.

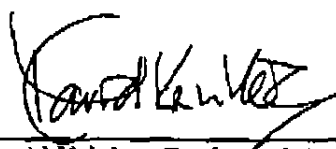
