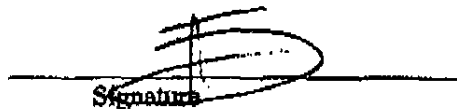
This corporation shall have 1 director initially. The number of directors may be increase or diminished from time to time by the Bylaws adopted by the Stockholders, but shall never be less than one.
