Articles of Incorporation pf

Young Minds Soaring High, Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501 (c)(3) of the Internal Revenue Code, including, for such purposes, the making of Distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of Purpose for which this corporation is organized is to be able to do employment services for VR, to serve the community.
