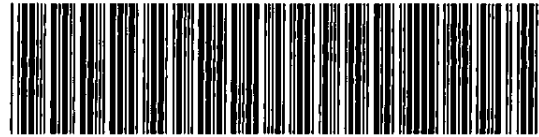

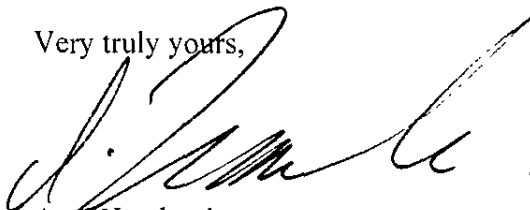

AMENDMENTS TO ARTICLES OF INCORPORATION**

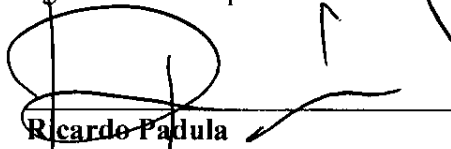

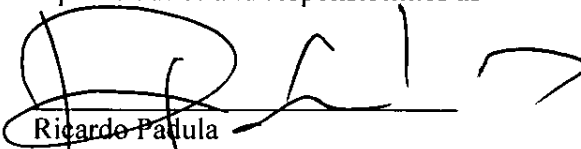
