

# ARTICLES OF INCORPORATION OF

## SUNSHINE DIAGNOSTIC IMAGING INC.

### ARTICLE I

#### Name of Corporation

The name of this corporation is SUNSHINE DIAGNOSTIC IMAGING INC.

### ARTICLE II

#### Purpose

Organized primarily as a provider of radiological services including x-rays, ultrasounds and EKGs, SUNSHINE DIAGNOSTIC IMAGING INC. will, with the approval of its Board, transact any and all lawful business permitted under the laws of the United States and the State of Florida.

### ARTICLE III

#### Capital Stock

Initially, this Corporation is authorized to issue 10,000 shares of common stock at \$0.01 dollar par value.

### ARTICLE IV

#### Corporate existence and Date of Operation




