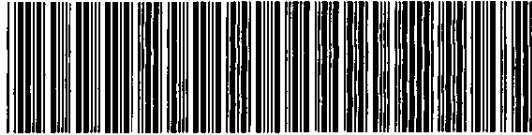

ARTICLES OF INCORPORATION  
OF  
RMA ARCHITECTURAL SERVICES, INC.

ARTICLE I - NAME

The name of this corporation is RMA Architectural Services, Inc. (hereinafter "Corporation").

ARTICLE I - DURATION

This Corporation shall exist perpetually, commencing on the date of filing of the Articles of Incorporation.

ARTICLE III - PURPOSE

This Corporation is organized for the following purposes: To engage in all facets of an architectural services business, and to do all or anything connected therewith or incidental thereto in connection with the foregoing, and for the purpose of transacting any or all lawful businesses of any kind or description permitted by law.

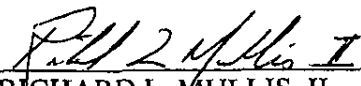
