In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I
NAME**

BUSINESS TO BE TRANACTED**

The nature of the business to be transacted by this corporation is:

To engage in the business of photography, for sale, resale, development, and marketing.






