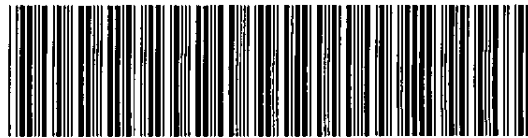




ARTICLE XI. AMENDMENT
