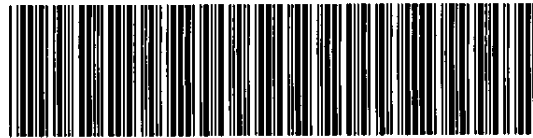

The undersigned, for the purpose of forming a corporation for profit under Florida law adopt the following articles of incorporation:

**ARTICLE ONE: NAME**

The name of the corporation is *LOPEZ FAMILY OF EIGHT, INC.*

**ARTICLE TWO: DURATION**

This corporation shall exist perpetually.

**ARTICLE THREE: PURPOSE**

The general purpose for which this corporation is being formed is to include transactions of any or all lawful business permitted under the laws of the State of Florida.

**ARTICLE FOUR: CAPITAL STOCK**

This corporation is authorized to issue eight hundred (800) shares of common stock of a par value of \$1.00 per share.

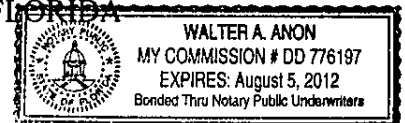
