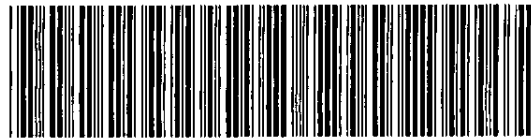

ARTICLES OF INCORPORATION

OF

JIMBO FISHER FOOTBALL CAMP, INC.

The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation of such Corporation.

ARTICLE I

The name of the Corporation shall be:

JIMBO FISHER FOOTBALL CAMP, INC.

The address of the principal office of this Corporation shall be Moore Athletic Center, 525 Stadium Drive West, Tallahassee, Florida 32306, and the mailing address of the Corporation shall be P. O. Box 2195, Tallahassee, Florida 32306.

ARTICLE II

The period of duration of the corporation shall be perpetual.

ARTICLE III

The Corporation is organized for the purpose of conducting and maintaining a camp for educational purposes and matters related thereto; notwithstanding, the Corporation shall have, and may exercise, all powers granted to corporations for-profit under the laws of Florida and may do all things necessary or convenient to carry out its business and affairs.

ARTICLE IV

The Corporation shall be authorized to issue 100 shares of capital stock, all of one class, with a par value of \$1.00 per share.



ARTICLE VII


The Board of Directors shall have the authority to adopt and periodically amend the bylaws of the Corporation.
