ARTICLES OF INCORPORATION

OF

ALIXIR CORPORATION



The undersigned, subscriber(s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves to form a corporation for profit, under the laws of the State of Florida.

ARTICLE I- NAME

The name of this corporation is: ALIXIR CORPORATION

ARTICLE II- NATURE OF BUSINESS

This corporation is organized for the purpose of dealing in all types of real, personal or intellectual property and transacting any and all lawful business, including but not limited to:

- (a) To provide full service opportunities for writers, musicians, and other artists to publish, distribute or market their works.
- (b) To acquire, by purchase, lease, manufacture, or otherwise, any real, personal, or intellectual property deemed necessary or useful in the equipment, furnishing, improvement, development or management of any property, real, personal, or intellectual at any time owned, held or occupied by the corporation and to invest, trade and deal in any real, personal or intellectual property deemed beneficial to the corporation and to lease, rent, encumber or dispose of any real, personal or intellectual property at any time owned or held by the corporation.
- (c) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes, or other evidences of indebtedness and to execute such mortgages, transfers or corporate property or other instruments to secure the payment of corporate indebtedness as required.
- (d) To purchase corporate assets of any other corporation and engage in the same or other character of business.

- (e) To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge, or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any state or government, and while owner of such stock to exercise all the rights, powers, and privileges of ownership, including the right to vote such stock.
- (f) To enter into, make, perform, and carry out contracts and agreements of every kind, for any lawful purpose, without limit as to amount, with any person, firm, association, or corporation, and to transact any further or other business necessarily connected with the purposes of this corporation or calculated to facilitate the same.
- (g) To carry on any and all of its operations in the State of Florida or elsewhere, without restriction as to place or amount; and to have, use, exercise and enjoy all the general powers of like corporations.
- (h) To engage in any and all lawful businesses, trades, occupations, and professions.
- (i) To do any and all of the things herein set forth to the same extent as natural persons might or could do and in any part of the world as principals, agents, contractors or otherwise, alone, or in company with others, and to perform all such other things and acts as may be necessary, profitable or expedient in carrying on any of the business or acts above-named.

ARTICLE III- CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 500,000 shares of common stock, each having the par value of \$1.00.

Authorized capital stock may be paid for in cash, services, or property, at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting.

ARTICLE IV- TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE V- ADDRESS
