The undersigned, for the purpose of forming a corporation under the Florida Business' Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name and Address

The name of the Corporation is Marcelo W. Mattschei, DDS, P.A. The mailing address of the Corporation is 300 Dunes Blvd., #1204, Naples, Florida 34110.

> Article 2. **Duration**

The duration of the Corporation is perpetual.
