

Pursuant to the provisions of Section 607.0124 of the Florida Business Corporation Act, the undersigned professional corporation adopts the following Articles of Correction to the Articles of Incorporation of Angel A. Unzalu, C.P.A., P.A.:

- 1. The document being corrected is the Articles of Incorporation for this corporation filed on May 27, 2010 under document no. P10000045771.
- 2. The defects to be corrected are (i) a scrivenor error in Article THIRD wherein the word "medicine" should have been "accounting" and "physicians" should have been "accountants"; and (ii) a scrivenor error in Article FOURTH wherein the words "real estate brokers" should have been "certified public accountants".
- 3. Article THIRD of the Articles of Incorporation is hereby deleted in its entirety and the following is substituted in its place:

**THIRD:** This corporation is formed to engage in the professional practice of accounting in the State of Florida and to do everything necessary, proper or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida or by the provisions of these Articles of Incorporation. The corporation shall carry out the above purposes through duly licensed or otherwise lawfully authorized certified public accountants.

4. Article FOURTH of the Articles of Incorporation is hereby deleted in its entirety and the following is substituted in its place:

**FOURTH:** This corporation is authorized to issue One Hundred (100) shares of common stock which shall be designated as "common shares". All of said stock shall be payable in cash, or payable in property (real or personal), labor or services in lieu of cash, at a just valuation to be fixed by the board of directors of this corporation. The shares of stock in this Corporation may only be issued to those individuals who are duly licensed certified public accountants in the State of Florida and stockholders of this Corporation may not enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his or her shares.

- 5. These articles of correction shall be effective as of May 27, 2010.
- 6. Directors and officers of this corporation have not yet been elected or appointed, as the case may be and therefore these articles of correction are being executed by Ted Klein as incorporator.
