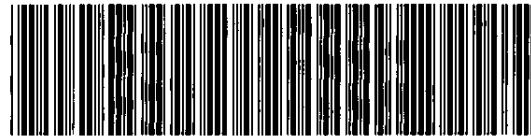

NAME

The name of the Corporation shall be

NATURE OF BUSINESS

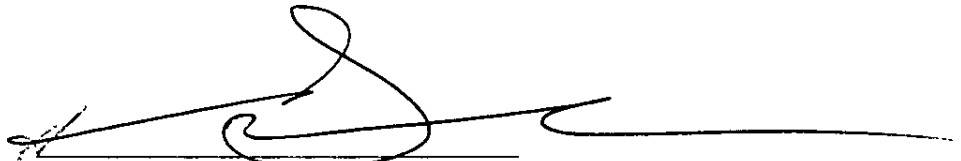

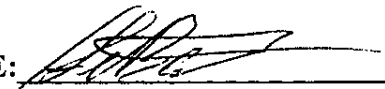
