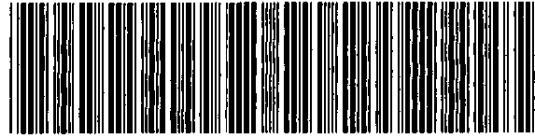

In Compliance with the requirements of F. S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

Article I

The names of the Corporation ("Corporation") shall be Reynoso Farm Inc.

ARTICLE II


