ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name and mailing address of this corporation shall be: -

NEW CHINA HOUSE RESTAURANT CORP. 2479 West 72nd Place Hialeah Florida 33016

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commerce its existence upon the signing of these Articles of Incorporation by the initial subscribers.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

Shares may not be issued until the full amount of the consideration for which shares are to be issued shall have been received by the corporation, such shares shall be deemed to be fully paid and honassesseable.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which be already holds,

shall have the right to purchase this pro ratashare thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
