
BE IT RESOLVED that Article I of the Articles of Incorporation is amended as follows:

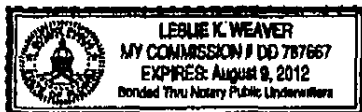
