#### ARTICLE I - Name

The name of this corporation is R & M MCNEAL LOGISTICS, INC.

#### ARTICLE II - Purpose

- 1. This corporation is organized for the purpose of transacting any and/or all-lawful business including, but not limited to, conducting the specific business of long haul trucking and all other related business matters.
- 2. To act on its own behalf in all legal or equitable proceedings or suits.
